The regular meeting of the Board of Trustees of the Rutland Dundee Fire Protection District was called to order at 6:12 p.m.

A motion was made by Trustee Gilbert to approve payment of the April bills, including check number 36597 through 36631 for a total of \$63,578.51, payroll liability for the month of April in the amount of \$175,256.73, and \$1,363.00 in electronic payments, for a total liability in the month of April of \$240,198.74. The motion was seconded by Trustee Carbone. A roll call vote was taken with Trustee Anderson voting yes, Trustee Gilbert voting yes, and Trustee Carbone voting yes.

A motion was made by Trustee Gilbert to approve the April Year-To-Date Treasurer's report as presented. The motion was seconded by Trustee Carbone. A roll call vote was taken with Trustee Anderson voting yes, Trustee Carbone voting yes, and Trustee Gilbert voting yes.

Attorney Weiler confirmed that the District will not have to prepare and file a Prevailing Wage Resolution this year.

Chief Thomas thanked all personnel for their good work at a recent fire on Pauline Court.

Deputy Chief Meyer and Lt. Rossi were able to complete the scraping and painting work in the entry way at Station #51.

Chief Thomas reported that the District had some difficulty with the Department credit card this week. The Chief will be looking into finding a different credit card company to use, going forward.

Department personnel have been participating in several birthday parades. FF Rohrbacher came up with a "goody" bag that can be given to the birthday child.

A motion was made by Trustee Anderson to approve Resolution FY2020-01, A Resolution Authorizing the Addition of the IPPFA Deferred Compensation Plan as an Employee Benefit as presented. The motion was seconded by Trustee Gilbert. A roll call vote was taken with Trustee Anderson voting yes, Trustee Gilbert voting yes, and Trustee Carbone voting yes.

A motion was made by Trustee Carbone to approve Resolution FY2020-002, A Resolution Accepting the Consolidation of the West Dundee Fire Protection District into the Rutland-Dundee Townships Fire Protection District, as presented. The motion was seconded by Trustee Anderson. A roll call vote was taken with Trustee Anderson voting yes, Trustee Gilbert voting yes, and Trustee Carbone voting yes.

A motion was made by Trustee Carbone to approve the FY2020 Working Budget with the following changes: removing the salt spreader for the new pick up truck, and using that money instead to purchase electronics for the new ambulance. The motion was seconded by Trustee Gilbert. A roll call vote was taken with Trustee Anderson voting yes, Trustee Gilbert voting yes, and Trustee Carbone voting yes.

With no further business to come before the Board, a motion was made by Trustee Gilbert to adjourn the Regular Meeting of the Board of Trustees at 6:48 p.m. The motion was seconded by Trustee Carbone. A roll call vote was taken with Trustee Anderson voting yes, Trustee Gilbert voting yes, and Trustee Carbone voting yes.
